- Children of all ages welcome.

Children in their own Suites - the first child pays the adult rate and second child will pay the child rate. Maximum of 3 extra children in camp at any one time.
- The Family Suites offer 2 en-suite rooms with a shared lounge in the middle and a plunge pool.
- All pools are unfenced. The Suite pools can be covered for safety while the central pool and pond is unfenced.
- The camp is surrounded by an electric fence to keep dangerous game out.
- No professional child minding is available; however the guides are able to entertain children during the day as required.
