

## MOZAMBIQUE eVISA & ETA

*A step-by-step guide for Gorongosa Safaris guests*

Mozambique now runs all visas and Electronic Travel Authorisations (ETAs) through a single online portal. Whether you need a full tourist visa or you're on the exempt list and only need the ETA, you'll run through the same process below. It takes about ten minutes to complete, and we've broken it into simple steps so nothing catches you out.

*Please read through to Step 11 before you start, so you know what to expect at each stage.*

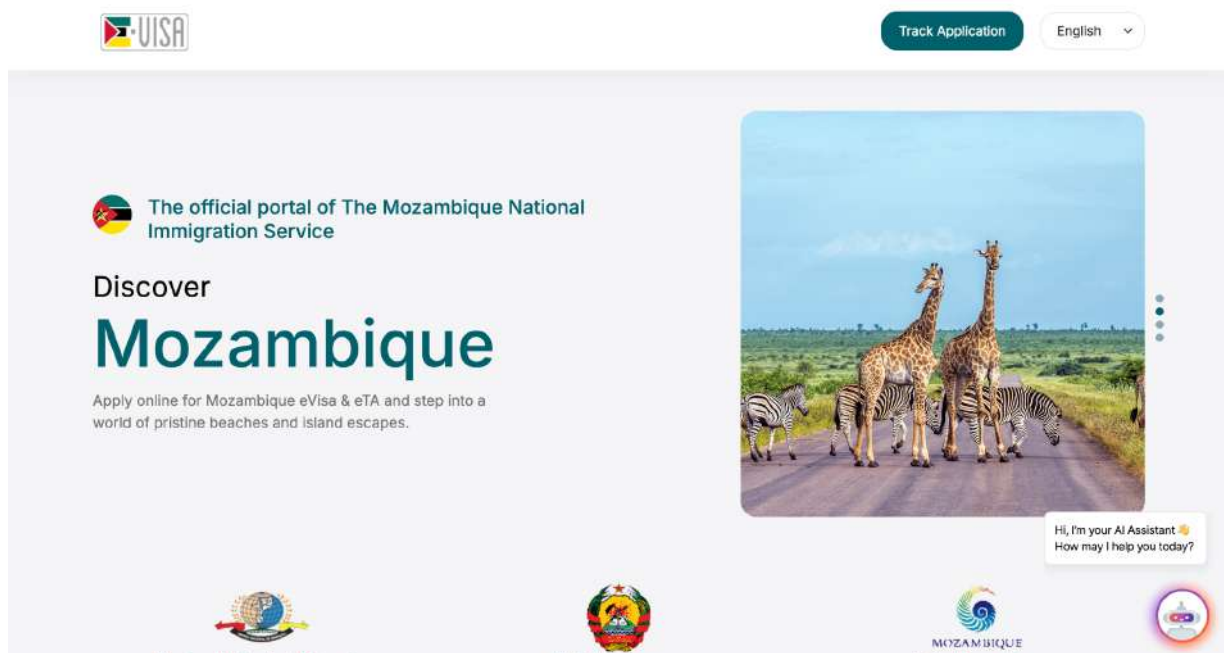
### STEP 1 Visit the eVisa website

Head to the site above and select the [Tourist Visa](#). If you're travelling with children under 18, read the additional requirements for minors before you begin.

Important note: you have to repeat this process for every traveller, and you cannot bulk-apply to all guests travelling.

#### *Travelling with minors*

- Each minor needs a signed parental authorisation form, downloaded from the portal and uploaded with their application.
- You'll also need the ID of the parent or guardian with parental authority, and a signed statement of responsibility.

## Tourist Visa

You may apply for this eVisa if your purpose of travel is tourism, holiday or vacation, including to visit our beautiful beaches or tasting our amazing prawns for a duration of 90 days or less.

### Entry

You can enter the country as per the duration of the visa 30, 60 or 90 days. The visa issued will be of multiple-entry type, determined based on the applicant's travel itinerary.

**eVisa Validity** The validity period of your eVisa is 2 months, you can enter Mozambique at any time within the eVisa's validity period, which begins on the date of issuance.

### Duration of Stay

Once in Mozambique, you are authorised to stay for up to the duration of stay mentioned on the approved visa. If you need to extend your stay, you must contact the Mozambique Embassy directly.

### Requirements

The documents below are mandatory for both the respective purpose of travel selected by the traveller.



#### Passport

Color copy of the passport bio page (valid more than 6 months)



#### Frontal Photo

A recent, passport-style photo

## STEP 2 Sign up and log in

Click Apply Now to sign up, and you will be taken to the VFS website. Use an email address you check regularly, as all correspondence and your one-time login PIN (OTP) will be sent there. Ensure to always check your junk or spam folder to ensure any emails have not been sent there.

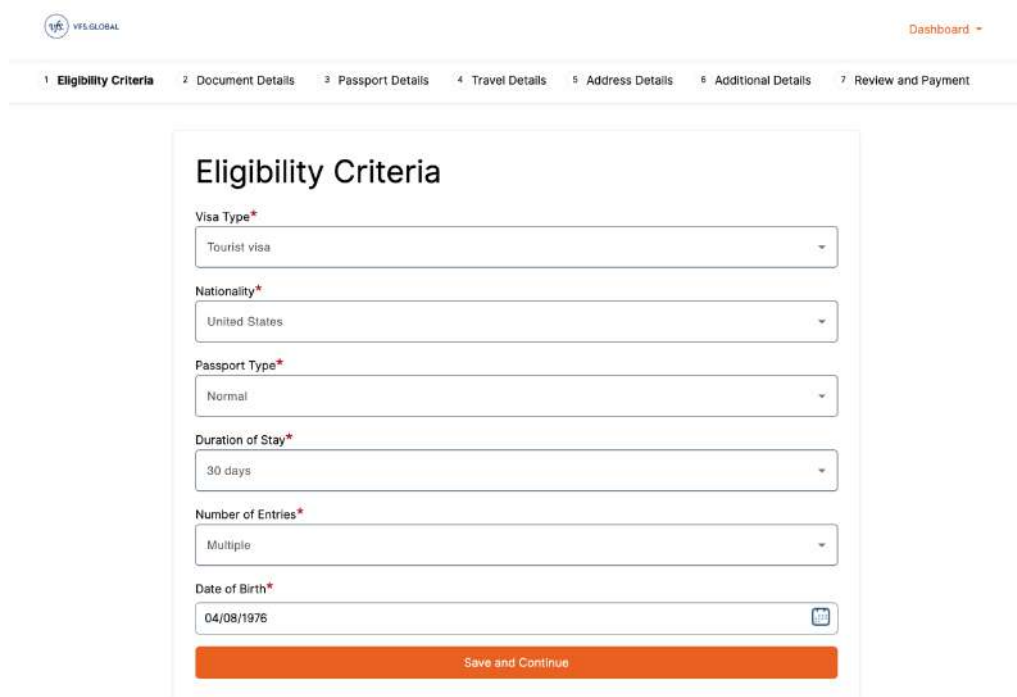

#### 4A. Passport-style photo

A selfie against a plain white wall works well. Look straight at the camera, no smiling, no glasses or hats, hair off the face, and shoulders visible in the frame.

#### 4B. Passport copy

Capture the full passport page with all four corners visible, in colour. A PDF under 2MB works best (a clear JPEG is fine too). You'll be asked for the passport number, issue date, and issuing authority (the country that issued your passport).



#### 4C. Financial proof

A letter confirming your bank account, or a recent statement showing available funds, both work. A copy of your credit card with the applicant's name and expiry date visible is also accepted (you can black out the card number). This requirement is still a bit of a grey area on the portal's side, so we'll update this guide as we learn more.

- Document Number: your card or account number (you may block out digits)
- Issue Date: the statement date, or your card's valid-from date
- Issuing Authority: your bank or card provider's name

#### 4D. Hotel reservation

#### 4E. Return ticket

#### 4F. Anything else

Add any additional supporting documents here if needed, then click Save and Continue.

### STEP 5 Travel details

The system reads your uploaded documents and asks you to confirm your travel details. For a Gorongosa Safaris trip, this typically looks like:

**Purpose of Travel:** Tourism Safari Stay

**Date of Arrival:** The date your flight lands in Mozambique

**Travel Mode:** Plane

**Flight Number:** Your Airlink or Ethiopian Airlines flight number into Beira

**Province:** Sofala

**Stay in Mozambique – Location:** Your Gorongosa Safaris property (Muzimu Lodge, Chicari Camp, or Expedition Camp)

**Stay in Mozambique – Street & House Number:** Gorongosa National Park

**Visa Issuance Location:** Aeroporto da Beira (Beira International Airport)

*Click Save and Continue once these are filled in.*

### STEP 6 Address details

You'll be asked for a residential address. It doesn't need to be your home; any address you're comfortable using is fine, as no proof of residence is required.

This page asks for a different email address to the one you signed up with, so use a second address if you have one. You'll also need your mobile number with country code, and a contact number in Mozambique. - If asked for extra documents, respond within the timeframe given; an incomplete application can be delayed or cancelled.
- Check your inbox and spam folder in case the confirmation lands there.

## STEP 11 Your approval

You'll receive an email titled Application Approved, with your Preliminary Visa attached as a PDF. Print two copies and keep them somewhere secure and easy to reach; you'll need them at check-in and again at immigration on arrival.
